# **FUNDRAISING AGREEMENT**

As part of your participation in the Wheels4Water: Cambodia ride in 2020, you are committing to raise enough money for one village (USD \$10,000) that will provide up to 200 vulnerable children and families with safe water. This is in addition to the costs for travel (flights, etc.) and outfitting (paid to Grasshopper Tours). You can contribute this amount (\$10,000 or more) yourself or you can fundraise among your family, friends, and coworkers.

We have found that including others in your fundraising commitment is a very rewarding and community-building experience, and we encourage you to let others know what you're doing! Lifewater will help you through the fundraising process and provide a personalized fundraising website where you can track online donations and send emails to supporters. We are also available to provide more ideas and support for fundraising along the way.

Ultimately, however, the commitment and responsibility is yours. This commitment helps us plan with confidence for the villages we serve and ensure meaningful engagement from each participant in the expedition. You will be required to provide a credit or debit card, and it will be automatically charged the difference between the funds raised and \$10,000. (The final amount raised will be established on February 17th, 2020, and the account charged, if necessary, shortly thereafter.)

Until January 10th, 2020, if you decide to withdraw from the expedition, you can do so without having the obligation to reach your fundraising commitment. The funds you have raised will still go directly to the mission and you can always join us again in the future.

By signing this release, I also hereby unconditionally, knowingly and voluntarily agree, on behalf of myself and my heirs, executors, and insurers, to the following terms, conditions and policies:

· I waive, release, and hold harmless Lifewater, its executive committee, steering committee, employees, directors, agents, expedition leaders, and all others from all claims, causes of action, damages, costs, fees, personal injuries, death and other expenses which may arise directly or indirectly from my participation in the Expedition, unless caused by Lifewater's gross negligence or reckless conduct. This release includes, without limitation, all rights or claims arising under any applicable state or federal statute, foreign law, international law or any common law cause of action, including any claims for attorneys' fees or other costs.

I assume the risk of these things happening.

- I understand that I am fully responsible for my health before, during, and after the Expedition. I understand that I am responsible for consulting with my personal physician prior to the Expedition to ensure that I am healthy and physically capable of participating in the Expedition. I understand that I should also consult with my physician and/or International Travel Office regarding required immunizations.
- I understand that accidents, injuries, illnesses or other occurrence may occur in the course of travel to and from and participation in the Expedition. I understand that

- Lifewater is not responsible for payment of any costs, fees or expenses that may arise as a result of an accident, injury, illness or other occurrence in the course of travel to and from and participation in the Expedition. I understand that Lifewater cannot guarantee that adequate treatment, supplies or transportation will be available. If treatment or other care or services are provided, Lifewater and those providing treatment and care do so as "Good Samaritans" and with the expectation that they have no legal or other liability as a result of providing such gratuitous services.
- I understand that I am fully responsible for obtaining adequate health, life, disability, and casualty insurance coverage, including evacuation insurance, covering my travel to and from and participation in the Expedition. I am also fully responsible for securing any other necessary financial arrangements to provide for any and all costs, fees, damages or other expenses which may arise as a result of my participation in the Expedition. I understand that Lifewater is not responsible for any costs, expenses, fees, or damage to personal property incurred in the course of traveling to or from or participating in the Expedition, including but not limited to loss of
